Notice for Admission under Management Quota for Academic session 2026-27

Management Quota Application Forms are invited by ADGIPS for various categories of seats in B.Tech., B.Tech.(LE), Integrated BBA LLB (Hons.), Integrated BA LLB (Hons.), & BBA. Candidate can apply online/offline in the Institute (during 11 A.M. to 1 PM – Monday to Friday, except Saturday, Sunday & Gazetted holidays) and its website with facility of downloading of Application Form from 14th July 2026 (5.00 P.M) to 31st July 2026 (2.00 P.M). No registration fee of Rs. 2500/- for management quota admission will be charged by the Institution. Incomplete Application Forms/Documents will not be considered. The Candidates shall be required to complete all the Admission Formalities as per the Provisions of GGSIP University & other important orders relating to management quota admission.

ADMISSION NOTICE

Management Quota Admissions (Academic Session 2026–27)

Applications are invited from eligible candidates for admission to **B.Tech (First & Second Shift), B.Tech (Lateral Entry – First & Second Shift), BBA (First & Second Shift), Integrated B.A. LL.B., and Integrated B.B.A. LL.B.** under the **Management Quota (10% of the sanctioned intake)** for the Academic Session **2026–27**.

Admissions shall be conducted strictly in accordance with the eligibility criteria, admission procedure, and guidelines prescribed in the **GGSIPO Admission Brochure 2026–27**. Candidates are advised to refer to the University Admission Portal and the Institute website for detailed information and regular updates.

Application Process

Candidates may apply for admission under the Management Quota through the **online application form** available on the Institute website from **14 July 2026 to 31 July 2026 (Monday to Friday, excluding Gazetted Holidays)**.

In case of difficulty in submitting the online application, candidates may submit the **offline application form**, which can be downloaded from the Institute website. The duly filled offline application form must be submitted at the Institute between **14 July 2026 and 31 July 2026**, from **11:00 AM to 1:00 PM** on working days.

Admission Criteria

Admissions under the Management Quota shall be made **strictly on the basis of merit** determined by the marks obtained in the qualifying examination, subject to fulfillment of the eligibility conditions prescribed in the **GGSIPO Admission Brochure 2026–27**.

The **programme-wise seat matrix, reservation policy, merit list, and counselling schedule** will be published on the Institute website.

Candidates must also have qualified the **National Level Test (NLT) 2026** or the **University CET 2026**, wherever applicable. **Vacant seats, if any, after exhausting the NLT/CET merit list, shall be filled through CUET, wherever applicable, as per university guidelines.**

No request or correspondence regarding Management Quota admissions received through **e-mail, post, or fax** shall be entertained by the Institute.

Important Instructions

Candidates are advised to read the following instructions carefully before applying:

1. Enter all personal and academic details exactly as recorded in the relevant certificates and documents.
2. Verify all information before submitting the application. Incorrect or incomplete information may lead to rejection of the application.
3. Candidates are advised to complete the admission process personally and should not deal with unauthorized agents, touts, or consultants.
4. The duly filled **offline application form**, along with all prescribed supporting documents, must be submitted in person.
5. Candidates must appear personally with all original documents on the scheduled counselling date. Failure to do so shall result in cancellation of candidature.
6. Applications must be submitted within the notified time. Applications received after the prescribed hours shall not be accepted.
7. Entry to the campus shall be permitted only to the candidate and **one parent (Father/Mother)**. A valid Government-issued photo identity card (Aadhaar Card, Passport, PAN Card, Driving Licence, Voter ID, etc.) must be produced at the entry gate.
8. Mobile phones, laptops, tablets, smart watches, cameras, electronic gadgets, and bags (where restricted) are not permitted inside the campus. The Institute shall not be responsible for the loss of any personal belongings.
9. Candidates seeking reservation under **SC/ST/DEF/PwD or any other applicable category** must produce the prescribed original category certificates. Failing this, the candidature shall be considered in accordance with the applicable University norms.
10. Candidates must regularly visit the Institute website for announcements, merit lists, counselling schedules, and other admission-related updates. Failure to do so shall be the sole responsibility of the candidate.
11. The decision of the Competent Admission Authority/Institute shall be final and binding in all matters relating to Management Quota admissions.
12. Admission shall be subject to fulfillment of eligibility conditions, verification of original documents, and approval of the competent authority. Submission of an application does not confer any right to admission.
13. The Institute reserves the right to reject any application that is incomplete, incorrect, illegible, or not supported by the prescribed documents without assigning any reason.
